We have received support from both Integrated Continuing Care Steering Committee (ICSC) and Clinical Operations Executive Committee (COEC) on the Palliative and End of Life Alberta Provincial Framework (<http://insite.albertahealthservices.ca/sh/tms-sh-provincial-palliative-end-of-life-care-framework.pdf>).

Based on the framework, a set of initiatives were identified as Year 1 priorities and were documented into program and project charters. These charters were endorsed by the Provincial Palliative and End of Life Innovations Steering Committee (ISC) over the summer and also supported by COEC.

The PEOLC program strives to be evidence based, using an integrated approach with the solutions resulting in greater services and support for all Albertans. Your expert knowledge regarding clinical best practices, policies, and implications for patient care within your respective areas will ensure that this work moves forward.

## Advance Care Planning / Goals of Care Designation




The ACP/GCD initiative will be initiating its 1 year review of the policy and procedure this fall under the guidance and support of the ACP/GCD Provincial/Zone Implementation Committee. In addition to reviewing the policy and procedure, the Provincial ACP/GCD team will also review ACP/GCD tools, resources and web content to ensure they reflect the updated policy, and engage Health Care


# Palliative and End of Life Initiatives Update

ISC met on September 22, 2014 to review and endorse the direction and essential components of the year 1 initiatives.




## Provincial PEOLC EMS Assess, Treat, and Refer Project

- Preliminary dispatch protocol and work flow protocol have been drafted. These will be brought forward for endorsement at the next ISC meeting.
- There have been discussions around the identification of palliative patients and emergencies to be treated.
- Working group will be developing two additional program models for consideration.



## 24 / 7 Provincial Palliative Physician Support

- Current state analysis in process.
- Discussion with zone medical directors in process.
- A meeting is planned with Physicians from British Columbia to learn about their provincial on-call process
- Working group of all zone medical directors will meet in the near future to recommend a high level plan to be endorsed at ISC.



## Pathways / Guidelines

- Working group has been established.
- Completed an environmental scan and gaps analysis across Alberta.
- Will be developing a plan to recommend to ISC on how to integrate PEOLC into existing and future care pathways work.



## Dashboard

- Academic review of PEOLC indicators completed
- Working group has identified 10 Alberta specific indicators which were endorsed at the ISC.
- Further discuss and finalise the endorsed Alberta specific PEOLC quality indicators to be utilized within the dashboard.



## Multiyear PEOLC Strategy & Business Plan

- 36 initiatives consolidated into ten groups with a timeline until 2017/18 fiscal year.
- Components of business plan to be endorsed by ISC.



## Capacity

- We will assist the Supportive Living & Long Term Care Development strategy department to support this work moving forward.
- Focus this year will be to determine the number of all PEOLC spaces and service requirements for both rural and urban area in hospital and community settings per 100,000 adjusted population.




## Website

## Edmonton Zone

### New to the palliative care community

The Edmonton Zone Palliative Program is pleased to announce the expansion of the hospice program to include a four bed hospice at WestView Health Centre in Stony Plain. The hospice is collocated with the continuing care at WestView Health Centre. This expansion will increase the number of inpatient hospice programs to four and the number of Edmonton Zone Palliative hospice beds to 68. This is the first suburban inpatient hospice in the Edmonton Zone. The WestView hospice will complement the current palliative services and provide a full range of supports for the WestView community.

Royal Alexandra Hospital

In November 2014, the Royal Alexandra Hospital Medicine Program is planning to open 9 designated palliative spaces. These private and semi-private rooms will be for C2 goals of care designation patients whose length of stay is predicted to be hours to days of life and the option to transfer elsewhere, such as hospice, is no longer possible. Attending physicians throughout the Royal Alexandra Hospital will be able to request their patients be moved to this unit where they will be able to work with an interdisciplinary team educated in the care of end of life patients. The Royal Alexandra Hospital Palliative Care Consult Program will be a resource in educating and supporting the staff.

# The Way Forward: An Integrated Palliative Approach to Care



**96%** of Canadians SUPPORT hospice palliative care.

**96%** BELIEVE it is important to have a conversation with loved ones about their wishes for care.

**13%** only, have COMPLETED an advance care plan to communicate their wishes.

**73%** want more INFORMATION from their doctors so they can plan and begin these important conversations.

## Talking about Advance Care Planning (ACP)

Less than one quarter of Canadian general practitioners and family physicians (GP/FPs) and nurses are experienced and comfortable talking about planning for illness and end of life with their patients through advance care plans.

**24%** of GP/FPs and **32%** of nurses have NO experience and are not comfortable with conversations.

**24%** of GP/FPs and **18%** of nurses ARE experienced and comfortable with ACP conversations.



**52%** of GP/FPs and **51%** of nurses have SOME experience but are not very comfortable with conversations.

## Perceptions of When People Should Start Advance Care Plans

**41%** FP/GPs and **61%** Nurses Believe people should start Advance Care Plans when they are **healthy**.

**31%** FP/GPs and **13%** Nurses Believe people should start Advance Care Plans when they are diagnosed with a **chronic illness**.

**22%** FP/GPs and **20%** Nurses Believe people should start Advance Care Plans when they are diagnosed with a **life-threatening illness**.



## WANTED: Tools and Resources

Based on the research, there are several gaps to fill with support, education and resources that would benefit family physicians, nurses and their patients:

- Overall comfort level in discussing palliative care and end-of-life issues;
- Providing end-of-life care independently and with confidence;
- Initiating discussions about a palliative approach and hands-on experience with advance care planning;
- Managing the non-medical needs related to end of life (e.g. accessing services; probing wishes after death);
- Managing challenging issues such as control of pain and depression; and
- Identifying resources in the community to provide support to patients and families.
